Madane Rural Municipality, Gulmi invites electronic bids from Nepalese eligible bidders for the construction and Improvement **Construction of Sefaltina purkotdaha kota water supply**, Gulmi under National Competitive Bidding procedures. The estimated amount for the works is Rs 6864152.76 (Including VAT& PS).

3. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document NRs. 3,000.00 (Non-refundable) in the Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held.
5. Only electronic bids must be submitted through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 hrs of 05/1/2020. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs of 05/1/2020 at the office of Madane Rural Municipality purkotdaha Gulmi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 175000 which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days). (Security in the form of cash should be deposited in the Deposit account A/C No.: 0425401499748041, Account Name: Madane Rural Municipality Gulmi, Bank name: Agriculture devpoment Bank, Purkotdaha, Gulmi)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. If a bidder submits above several successful (lowest evaluated substantially responsive) bids for the above contracts, the evaluation will also include an assessment of the bidder's capacity to meet the aggregated requirements regarding: Experience, Financial Situations, Cash flow capacity, Equipment to be allocated and Personnel to be fielded.
9. The person, firm or company black listed as per Public procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firm or company shall be ineligible to submit the bid from another new firm or company.
10. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 with amendment and Public Procurement Regulations-2064 with amendment and other prevailing regulations
