1. The Government of Nepal [GoN] has allocated funds towards the cost of Construction of Administrative Office Building of Madane Rural Municipality, Gulmi. And intends to apply part of the funds to cover eligible payments under the Contract for Construction of Administrative Office Building of Madane Rural Municipality, Gulmi (Contract No: OMDRM-GUL-W-NCB-17-077/78). Bidding is open to all eligible bidders as per Section V of Bidding Document
2. Office of Madane Rural Municipality invites electronic bids from eligible bidders for the Construction of Administrative Office Building of Madane Rural Municipality, Gulmi under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 9,67,00,000.00
 - Minimum Work experience of similar size and nature: One Contracts with a value of at least NRs. 7,74,00,000.00

4. Bidder should submit their bid electronically and shall download the bidding documents from PPMO's WebSite www.bolpatra.gov.np/egp should deposit the cost (NRs 10,000 .00) of bidding document in the following Bank till 7th May, 2021 on the office account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Pre-bid meeting shall be held at the Office Madane Rural Municipality, Purkotdaha, Gulmi, Lumbini Province at 27th April, 2021 at 13:00 hours.
6. Electronic bids must be submitted to the Office of Madane Rural Municipality, Purkotdaha, Gulmi, Lumbini Province, through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 7th May, 2021 at 12:00 hours. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 7th May, 2021 at 13:00 hours at the Office of Madane Rural Municipality Purkotdaha, Gulmi.
8. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 27,30,000.00 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Matter not covered in this notice shall govern in accordance with Public Procurement Act 2063 (Latest Amendment) and Public Procurement Regulations, 2064 (Latest Amendment) and other prevailing rules and regulations.
